2009-2010 RENEWAL OF AFFILIATION

Affiliation dues cover the fiscal year beginning June 1 and ending May 31. The affiliation dues schedule is based on the number of members your Affiliate has as of June 1. **Dues are non-refundable.** New Affiliates pay dues beginning with the affiliation year that follows the annual meeting at which they receive their charter.

No later than June 1, 2009, please return a completed 2009-2010 Renewal of Affiliation form with a check in U.S. funds payable to the National Council of Teachers of Mathematics. Retain a copy for your files. If payment is not made by June 1, 2009, an Affiliate's status will be *Not In Good Standing* and the group will not be eligible for services until payment is confirmed. Payments from Affiliates that owe dues for a previous year will first be applied to the previous year's balance. If affiliation dues become one year past due, an Affiliate is eligible to have its charter withdrawn.

Take advantage of the early payment discount by paying affiliation dues by March 3, 2009. (Dues payment must be postmarked by March 3, 2009 to be eligible for the discount.) **Please submit a completed 2009-2010 Renewal of Affiliation form with all payments.** The NCTM Representative and treasurer will receive a revised Profile Sheet showing that dues were received.

- **Non-student groups with fewer than 75 members** are Associate Affiliates.
- **All state- and province-level Affiliates** are Partner Affiliates.
- **All Affiliates with 1500 members or more** are Partner Affiliates.
- **All other groups** (groups that have 75 members but fewer than 1500 members and **are not state- or province-level Affiliates**) may choose to be either a Partner Affiliate or an Associate Affiliate.
