We encourage you to take advantage of this resolution process that allows proposed resolutions to be shared with all delegates as part of the Delegate Packet. This will give each delegate and their board advance time to review and discuss their position on the proposed resolution and the delegates are prepared to participate in the Regional Caucus and Delegate Assembly.

Again, submit proposed resolutions to NCTM Headquarters by the November 2, 2020, deadline.
