Resolutions Passed by the 2015 Delegate Assembly

RESOLUTION O.NR.15.01

The new NCTM website, in phase 2, shall include a designated space for Affiliate leadership networking and communication. This space should be easily accessible, and designed to promote interactive discussions among Affiliates and with the NCTM board.

Rationale:

- 1) Affiliate leaders need an easily accessible space on the NCTM web site to communicate with other Affiliate leaders.
- 2) Affiliates need a space on the NCTM web site to **continuously** collaborate, share ideas, and suggest solutions to common issues.
- 3) Several years ago, the ASC was guaranteed that this web site would be available to the ASC members to reach their geographical areas with important information from the NCTM Board.
- 4) The NCTM board should be able to access this website to learn what concerns are being shared among the Affiliates to provide support to current needs.
