2021 NCTM VIRTUAL ANNUAL MEETING SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. OPEN TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND THE VIRGINIA, AGE EIGHTEEN (18) OR OVER. VOID WHERE PROHIBITED. NO PURCHASE OR DONATION IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SPONSORING ORGANIZATION: The name of this sweepstakes is the NCTM 2021 Virtual Conference Sweepstakes (“Sweepstakes”) and is sponsored by the National Council of Teachers of Mathematics (“Sponsor”). Sponsor is a non-profit corporation headquartered in Virginia with mailing address of NCTM, 1906 Association Drive, Reston, VA 20191.

DESCRIPTION: Eligible NCTM members who register for the 2021 Virtual Annual Meeting, which will be held online April 21-May 1, 2021 (the “Event”) or who submit an Alternative Entry pursuant to the process below will automatically be entered into a drawing for a chance to win one of three professional development packages (the “Prize”).

SWEEPSTAKES PERIOD: Individuals meeting the eligibility requirements set forth below may enter the Sweepstakes between 10:01 a.m. (ET) February 15, 2021 and 11:59 p.m. (ET) April 16, 2021 (“Sweepstakes Period”).

ELIGIBILITY: By participating, entrants agree to be bound by these official rules (“Official Rules”) and the decisions of the Sponsor. **Entries received after the expiration of the Sweepstakes period are not eligible to win.**

To be eligible to win entrant:

- i. Must be at least eighteen (18) years of age at the time of entry and a legal resident of the fifty (50) United States. Void in Puerto Rico and where prohibited or restricted by law.
- ii. Must be a current NCTM member who has registered for the NCTM 2021 Virtual Annual Meeting through NCTM's official registration process during the Sweepstakes dates; or
- iii. Must be a current NCTM member at the time of entering the sweepstakes through the Alternative Entry process detailed below.

Paid employees of NCTM, Board of Directors or NCTM vendors/suppliers and their immediate family members (spouse, mother, father, in laws, grandmother, grandfather, brother, sister, children and grandchildren) are not eligible to win.

HOW TO ENTER: No purchase or donation is necessary to enter or win the Sweepstakes. A purchase or donation will not increase your odds of winning.

Entrant may enter the Sweepstakes by:

- I. Registering for NCTM's 2021 Virtual Annual Meeting during the sweepstakes dates; or
- II. ("Alternative Entries") Submitting a full name, address, phone number, email address to <https://nctm.link/e553w>

All entries must be received by Sponsor prior to the expiration of the Sweepstakes Period.

PRIZES AND ODDS OF WINNING: Pursuant to these Official Rules, Sponsor shall make available and award to three individuals one (1) professional development prize package. The verifiable retail value of each individual Prize is for the full value of two professional event registrations, NCTM Premium Membership and a library of NCTM publications valued up to \$800. Any other charges, including ticketed events, or workshops (along with respective taxes) at the NCTM events are to be paid at the registrant's expense. **Limit one entry per person.**

The Prize shall be awarded through a random drawing from the eligible entries Sponsor receives during the Sweepstakes Period. The odds of winning depend on the number of registrants for the event and the number of eligible alternative entries received. The decision of Sponsor regarding the selection of winner(s) shall be binding. Winners may not substitute, transfer, or assign Prizes. No Prize can be redeemed for cash or replaced if lost or stolen. Sponsor reserves the right to replace and/or substitute a like prize of equal value, should the specified Prize be unavailable for any reason.

WINNER NOTIFICATION: The Prize drawing shall be conducted on or before April 21, 2021 and winners will be notified by email. Return of prize notification as undeliverable within a 24 hour period may result in disqualification and an alternate winner may be selected from among all remaining eligible entries. If a potential winner cannot be contacted or does not respond to Sponsor within 24 hour (1) calendar day from the date Sponsor first tries to notify winner, such potential winner forfeits all rights to win the Sweepstakes or receive the Prize, and an alternate winner may be selected from all remaining eligible entries.
